The main campus of the University is located at the outskirts of Vijayapura. The beautiful campus spread over 281 acres. The campus has been beautifully landscaped. The campus inhibits natural greenery and its beautiful buildings, green trees, green lawns/park, open corridors and large playgrounds makes an academic environment for its students and faculty members to learn, develop skills and nurture teaching learning process. A majority of the students belonging to first generation learners particularly from rural areas are pursuing various courses offered by the University. The University offers diverse resources for students for creating inventiveness physical, creative, peaceful and eco-friendly environment for learning at the campus. The vision of the University is to empower the women through education. The academic thrust of the University lies in its unique service of providing education from post graduation to doctoral levels. Presently, the University offers 32 PG Programmes along with PG Diploma and Certificate programmes. To avoid wastage of rain water and reduce degradation of water, a major reservoir spread over 2 acres, with an average depth of 10 feet, by draining rain water passing through the different parts of the campus and adjoining areas. The natural landscape and academic ambience has been maintained while constructing new buildings in the campus. Numerous parking facilities have also been provided in the campus. The University has a basic Health Care Centre to provide medical support to needy students and staff members. Further, the University has empanelled couple of hospitals to provide medical facilities to the staff. Efforts are made to have accessibility for Differently-able person to most of the University buildings through ramps. Efforts are underway to extend ramps/lift/toilet facilities to all the University buildings. The University provides modest funding to all the Departments of the University to organize National/International Workshops/Seminars/Conference on topical issues regularly to enrich students' knowledge. The University allocates budget to all the Departments to invite experts and industry professionals for Extension/Special lectures. The University encourages faculty through funding for minor research and innovation projects and provides grants from Rs. One lakh to Two Lakhs. To utilise the available resources and facilities, various departments of the University have been placed in the same building. All the class rooms are well furnished and ventilated. There is the VC Banglow, Guest House, which has well furnished accommodation to accommodate 84 guests and Shikshakar Samudhay Bhavan, which can accommodate 10 to 15 guests. Presently, there are four Girls Hostels, which accommodates 675 girls. The University has two functional canteens in the main campus with the total area of 2528 sq. ft. and 1480 sq. ft. The university has a parking sheds near all the Buildings. The campus in very well connected with Tar Road of 3.3 km double road and 1.68 km

single road. The University have installed the water purifier in all the hostels, near ADM building, Science Block and Social Science Block. The University has also a Bank, ATM, a stationary shop and a shop for basic amenities. The University has five auditoriums

#### 7.1.7 – Initiatives taken by the institution to make the campus eco-friendly (at least five)

i. Solid waste management: Administrative offices and Departments send all the waste papers, files, card boards to the paper recycling unit of the university. Waste papers collected are properly recycled and manufactured into files, folders, visiting cards etc., and distributed among the offices and departments of the university. The solid waste from the garden and food waste from hostels and canteen are sent to the vermicomposting unit of the university. University campus is maintained plastic free. Previous Answer booklets of examinations are disposed of to the vendors with security license through tender process. Scrap materials such as broken furniture's are auctioned to suitable vendors through tender process. ii. Liquid waste management: Department collects the liquid wastes mainly solvents, acids and other harmful chemicals and carefully disposes them into the septic tank. iii. Biomedical waste management: Biomedical wastes generated at the University Health Centre are collected in different colored bags/buckets. The yellow bucket is used to collect injection, used bandages and cotton or any other things in contact with body fluids / human body parts, human anatomical wastes, solid biomedical wastes etc. In red buckets, fluid blood chest drains units/ catheters suction, IV tubes, microbiology and biotechnology wastes are collected. All types of glass bottles, broken glass articles, outdated discarded medicines, solid plastics are collected in blue buckets. Black buckets are used to collect destroyed needles without syringes, blades, sharp and all metal articles. The biomedical wastes generated are discarded in separate tank constructed at the University campus. iv. E-waste management: Computer waste and electronic waste generated are sent to the store section of the University to be sent for safe disposal to authorized vendors. v. Waste recycling system: In the Bio diesel unit, the byproducts generated such as seed cakes, glycerin and phenol are used as bio fertilizers, soaps and cleaners respectively.

#### 7.2 - Best Practices

#### 7.2.1 – Describe at least two institutional best practices

AKKA TV, YouTube Channel: AKKA TV a YouTube Channel is launched with the objective of giving hands on experience to the students of Journalism and Mass Communication in the process of TV news production. Since its launch, AKKA TV has been used as a medium of publicity for university programmes. It is serving various purposes such as to live telecast of major programmes of the university, to provide an online platform for webinars and online workshops, to generate online video contents, etc. So far AKKA TV has got as many as 18700 active subscribers over 500 videos have received nearly 7 lakh total views. The students of Journalism and Mass Communication have been producing news bulletin everyday, which includes news items of leading issue of the day and the news items of university programmes and activities. So far, the department of JMC in collaboration with other departments have launched many educational and entertainment programmes through AKKA TV. K-SET online Training, Online Course in Spoken English, Swara Sanje, Dhristi Sharadotsav, Travel Time, NET online coaching, TET Coaching are some of them. Women Technology Park ( Green House, paper recycling unit, Biodiesel ID centre) Three innovative activities are

undertaken i.e., Green House, Paper Recycling Unit and Biodiesel I D Centre. Green House (Poly house) structures were established under RUSA Programme to train the life sciences students for various skills mentioned in the objectives and further, training was extended to nearby farmers. Propagation of medicinal and vegetable plants was made by the students of M.Sc Botany during the course. Large of number of tree sapling are propagated throughout the year to cater plantation need of the university. Experimental Demonstration is given to the students of M.Sc Botany and Biotechnology to grow the various saplings in controlled conditions ( ex. Cultivation of strawberry ). Vegetables and fruits are grown in the green house to generate revolving fund. Green house wastes are being converted to varmiwash and vermicompost. Paper recycling unit was established to recycle the waste paper generated at K.S.A.W.U.Vijayapura. The produced products are being used by the university. Every month nearly 600 files are produced by waste paper recycling. Biodiesel I D-Centre was established in collaboration with State Bio-fuel Board, Government of Karnataka for training, awareness and demonstration of biofeul production. Biodiesel unit produces good quality neem cake and oil, which are being sold to the nearby farmers.Training and awareness programmes are conducted to produce biodiesel from waste cooking and non-edible oil.
