UNIT 1: PROCESSING OF FOODS

Cereals Processing, Pulse processing, Fruits and Vegetable Processing, Dairy, Meat, Fish and Poultry processing, Nutraceuticals & Functional Foods, Methods for testing of nutritional quality of foods (Proteins, Fats, Carbohydrates, Ash, Dietary fiber, Vitamins & Minerals), Use of GC, HPLC, LC-MS, GC-MS, ICP-MS, Spectrophotometer, Spectrofluorimeter and atomic absorption spectrophotometers (AAS)

UNIT 2: ADVANCES IN NUTRITION

Chemistry and mechanism of action of vitamins, minerals, lipids, proteins, fats carbohydrates, phytochemicals and hormones, *advances* in metabolism related to all nutrients including water and fibre – food and drug interaction – toxicants in foods – insecticides, heavy metals, carcinogens and natural toxicants – application of biotechnology to nutrition and xenobiotic.

UNIT 3: THERAPEUTIC NUTRITION


Formulation of therapeutic diets – problems and factors affecting the formulation of therapeutic diets methods of feeding – total parenteral nutrition-etiology manifestation and dietary treatment in the disorders of gastrointestinal tract, kidney, cardiovascular system, inborn errors of metabolism, metabolic disorders, diabetes, hypertension and obesity- nutrition in surgical conditions, fevers, infections, burns, allergy and for alcoholics diet counseling, Geriatric nutrition-metabolism diet.

UNIT 4: COMMUNITY NUTRITION

Study of national nutritional problems – maldistribution and failure of establishment-implications for agricultural strategy, impact of population explosion and food availability – food demand of groups at risk of malnutrition – food crisis, security system – Health and nutrition policy, strategies, outcome. Nutrition surveillance – methods – utility. Nutrition programme – planning, execution, evaluation.


